We will be bringing this renewal application before the Chairman of the Board of County Commissioners for his approval on Tuesday, February 3, 2026. Pursuant to the provisions of Resolution 2021-51, this is an administrative action which does not require a public hearing or formal action by the entire Board. This license has expired, but because a complete renewal application was filed with both the State Marijuana Enforcement Division (MED) and the local licensing authority, it remains valid until action is taken by the MED and the local authority.

RENEWAL CRITERIA

Nomadic, LLC submitted this application for the renewal of the retail marijuana cultivation facility license on November 21, 2025. The application has been going through the review process since that time. The final comments for this application were received on January 26, 2026.

Pursuant to the provisions of Section 9.04, of the Clear Creek County Marijuana Licensing Regulations, the approval criteria for approval of a new license shall be applicable to an application for renewal. Therefore, the Local Licensing Authority shall determine that all of the following requirements have been met by the Applicant:

1. The appropriate application is complete and the full application renewal fee has been paid; **The application was deemed completed December 11, 2025.**
2. The Planning Department has determined that the use is permitted and the owner or operator has obtained any required approvals under the Clear Creek County Zoning Regulations; **We recommend that the premises be found to comply with zoning.**

3. No zoning violations exist on the premises; **We recommend this be found satisfied.**
4. All existing or proposed signs meet the requirements of the Clear Creek County Zoning Regulations; **We recommend this be found satisfied.**
5. All existing or proposed lighting meets the Clear Creek County Zoning Regulations; **We recommend this be found satisfied.**
6. Any structure in which the use is located has been inspected by the Clear Creek County Building Official or her designee, the structure complies with all applicable building code provisions, and all necessary building permits have been obtained; **We recommend this be found satisfied.**
7. The premises comply with all applicable Site Development regulations including, but not limited to, driveway, grading, and BMP regulations; **We recommend this be found satisfied.**
8. The premises has all required well and sanitation system permits or is adequately served by public water and/or sewer; **We recommend this be found satisfied.**
9. Evidence of a legal water supply has been established for marijuana cultivation. **We recommend this be found satisfied.**
10. The premises are not subject to unresolved enforcement action by the Clear Creek County Department of Public Health and Environment; **We recommend this be found satisfied.**
11. The premises comply with the applicable Fire Code; **We recommend the premises be found to comply with the applicable Fire Code.**
12. All personal property tax schedules related to the Premises have been submitted timely and are complete. **We recommend this be found satisfied.**
13. All property taxes have been paid and no tax liens exist on the premises; **We recommend this be found satisfied.**
14. All Clear Creek County Sales taxes have been timely reported and paid; **We recommend this be found satisfied.**
15. All Clear Creek County retail marijuana cultivation facility excise taxes have been timely reported and paid. **We recommend this be found satisfied.**
16. The applicant and premises are in compliance with all other applicable County regulations; **We recommend this be found satisfied;** and
17. The application, including any required attachments and submissions, does not contain a material falsehood or misrepresentation. **We recommend this be found satisfied.**
18. The Licensed Premises are located in a Location permitted by these Regulations. **We recommend this be found satisfied.**
19. The applicant is eligible for a state license for the activity at that premises as provided in the CMM Code, based on information provided by the state. **The State Marijuana Enforcement Division is still conducting their license renewal investigation for Nomadic's retail cultivation and has not yet issued its Conditional Licenses for that operation. That retail license has been administratively continued by the State MED pending the outcome of that investigation.**

Comments were received from all of the reviewing departments and are attached for your review and consideration. After review and inspection, this renewal application meets the criteria for approval.

We recommend the approval of this renewal application and the issuance of the related license. The Licensee is fully compliant with our regulations.

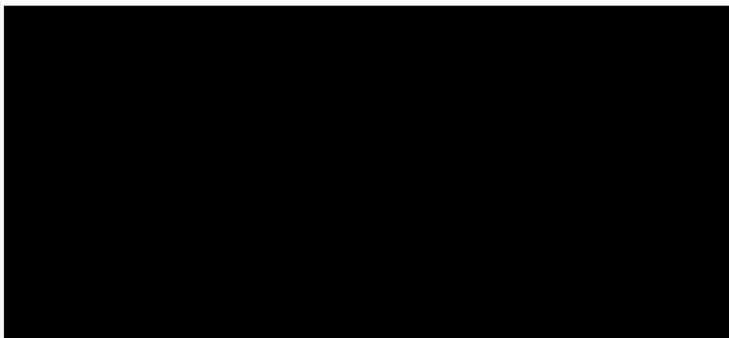
What current topics about the County concern you? (e.g., development, preservation, economy, revenues, housing, workforce, etc.): All of the

RECOMMENDATION

We recommend the Clear Creek County Board of County Commissioners (“Board”) approve the Memorandum of Understanding between the Board of County Commissioners of the County of Clear Creek, Colorado and Catholic Health Initiatives Colorado dba Flight for Life Colorado.

BACKGROUND

In November, 2025, John Kyler, our contract radio technician, was in contact with Flight For Life (“FFL”) Coordinator Travis McGrath regarding potential access to a fire detection camera located at the top of the county’s Bellevue telecommunications tower. Mr. McGrath expressed the need for access to this camera to assist Flight for Life with making informed decisions regarding their safety operations and current weather conditions. It was discussed that access to the current fire detection camera was not ideal, and that FFL could be better served by the installation of its own camera for their use.

ANALYSIS

FFL provides air ambulance services to our county residents and visitors to Clear Creek County. Having access to a camera which provides current weather conditions will allow FFL to fully assess the current weather conditions and make more informed decisions regarding its flight operations in the area.

CONCLUSION

We feel approving this agreement would be in the best interest of our residents and visitors to our county. It will FFL’s flight operations to be provided in a more informed manner.

FISCAL IMPACT

The cost to the County to power this equipment is minimal. Generally, our Public Safety partners are not charged for tower space, which we feel is a win-win for the County.

Memorandum of Understanding

This Memorandum of Understanding (“MOU”) is made and entered into as of the last signature date attached hereto (the “*Effective Date*”) by and among the Board of County Commissioners of the County of Clear Creek, Colorado (“**CCC**”) and Catholic Health Initiatives Colorado, a Colorado nonprofit corporation, d/b/a Flight for Life Colorado (“**FFL**”).

1. Purpose

The purpose of the MOU is to outline the terms, conditions and joint understandings between the parties regarding the allowance of FFL to place install a weather camera (“**Camera**”) on the Bellevue Telecommunications Tower which is owned and operated by CCC. This partnership aims to enhance operational effectiveness and safety of FFL’s flight crews and will provide significant benefits to Clear Creek County first responders and the community.

2. Scope

This MOU applies to the installation, operation and maintenance of the Camera on the Bellevue Communications Tower, located in the SW 1/4 of Section 22, T3S, R73W, 6th PM, in Clear Creek County, Colorado.

3. Entity Roles and Responsibilities:

FFL Agrees to:

- Provide, install, and maintain the weather camera and any associated equipment.
- Ensure that all equipment meets applicable safety and technical standards.
- Coordinate installation and maintenance activities with CCC to avoid interference with tower operations.
- Carry all necessary insurance for its equipment and personnel and provide CCC with a certificate of insurance to demonstrate this coverage.
- Remove the equipment upon termination of this MOU, unless otherwise agreed in writing.

CCC Agrees to:

- Permit FFL to install and operate the weather camera on the designated portion of the tower.
- Provide reasonable access to the tower for installation, maintenance, and removal activities, subject to safety and scheduling requirements.
- Notify FFL of any planned activities or changes that may affect the operation or location of the weather camera.

4. Costs

Unless otherwise agreed in writing:

- FFL shall be responsible for all costs associated with the purchase, installation, operation, and maintenance of the weather camera.
- No rental or access fee shall be charged by CCC for the placement, operation and maintenance of the Camera.

5. Term and Termination

This MOU is effective as of the Effective Date for a period of five (5) years or until terminated by either party, with or without cause, upon 30 days prior written notice to the other party. This MOU may be renewed or extended by mutual written consent of all parties.

6. Governing Law.

This MOU shall be governed by and construed in accordance with the laws of Colorado.

7. Indemnification

FFL shall indemnify and hold harmless CCC, and its elected officials and employees, and the agents of any of them, from and against claims, damages, losses and expenses including, but not limited to attorneys' fees, arising out of or resulting from FFL's installation, operation and maintenance of the Camera as allowed herein, including performance by anyone directly or indirectly employed by FFL or anyone for whose acts they may be liable. Notwithstanding the foregoing, each party is only responsible to the extent of its own negligence as it relates to the provisions of this MOU.

8. Liability

Each Party shall be responsible for its own acts, omissions, and equipment. Neither Party shall be liable for indirect or consequential damages arising out of this arrangement.

9. Privacy and Confidentiality.

The parties each agree to maintain privacy and confidentiality of all information obtained or collected in accordance with all applicable laws and regulations.

RECOMMENDATION

Staff recommends the Board of County Commissioners approve the Jobs for Veterans State Grant (JVSG) Program Memorandum of Understanding (MOU).

BACKGROUND

The Board participated in a work session on the JVSG on January 6, 2026, specific to The Workforce Innovation and Opportunity Act (WIOA) and the JVSG MOU.

WIOA is federal legislation passed in 2014 that requires states to align their workforce development programs to coordinate job seekers and employers in collaboration with partner organizations within the state and through the local workforce areas to improve the workforce ecosystem across the state, regionally, and locally.

As part of the required state/regional/local collaboration, each workforce area (in this case, the Tri-County Local Workforce Area (TriCo) which includes Jefferson, Gilpin, and Clear Creek County, TriCo is required to have specific partners to ensure universal access to services from any point of entry into the workforce system.

The Jobs for Veterans State Grants (JVSG) Program is a federal workforce initiative administered by the U.S. Department of Labor's Veterans' Employment and Training Services. Under JVSG, federal funds are formula-granted to state workforce agencies, including Colorado's, to hire dedicated veteran employment staff at local workforce centers. The goal of the program is to help veterans overcome employment obstacles, connect with job opportunities, and assist employers in meeting their workforce needs with qualified veteran talent. JVSG staff work in coordination with Workforce Innovation and Opportunity Act services, and veterans receive priority of services under both programs.

The Board last reviewed and signed the MOU on November 21, 2023.

FISCAL IMPACT

Infrastructure Funding Agreements in TriCo are an account of in-kind contributions to the workforce region based on direct infrastructure costs incurred by the partner to provide services to job seekers in the region. There are no cash contributions related to the WIOA MOU's.

TRI-COUNTY WORKFORCE AREA MEMORANDUM OF UNDERSTANDING

This Tri-County Workforce Area Memorandum of Understanding (this “MOU”) is entered into by and among the following parties (collectively, the “Parties”): (1) The Tri-County Workforce Development Board, the local workforce development board serving the Tri-County Workforce Area; (2) County of Jefferson, State of Colorado, a body politic and corporate (“Jefferson County”); (3) County of Clear Creek, State of Colorado, a body politic and corporate (“Clear Creek County”); (4) County of Gilpin, State of Colorado, a body politic and corporate (“Gilpin County”); and (5) Colorado Department of Labor and Employment, Division of Employment and Training, Jobs for Veterans State Grant Program (JVSG) (the “One-Stop Partner”).

RECITALS

- A. WHEREAS, the Workforce Innovation and Opportunity Act of 2014 (“WIOA”) requires the local workforce development board for each workforce area, with the agreement of the Chief Elected Official for that area, to enter into a memorandum of understanding with each one-stop partner operating in the workforce area concerning the operation of the one-stop delivery system in the local area;
- B. WHEREAS, the Tri-County Workforce Area, consisting of Jefferson County, Gilpin County and Clear Creek County, has been designated as a single local workforce area by the Colorado Workforce Development Council, on behalf of the Governor of the State of Colorado;
- C. WHEREAS, the Tri-County Workforce Development Board (the “TCWDB”) serves as the local workforce development board for the Tri-County Workforce Area;
- D. WHEREAS, Jefferson County has been designated the Chief Elected Official for the Tri-County Workforce Area by agreement of Jefferson, Gilpin and Clear Creek Counties; and
- E. WHEREAS, the One-Stop Partner identified above is a “Required Partner,” as that term is defined in WIOA.

AGREEMENT

NOW, THEREFORE, in accordance with the requirements of WIOA, the Parties agree as follows:

I. Term

The term of this MOU shall commence on the later of (a) January 1, 2026, or (b) the date this MOU becomes fully executed (the ‘Effective Date’) and shall end December 31, 2028, unless terminated earlier pursuant to the terms of this MOU.

II. Identification of Comprehensive Workforce Center

The TCWDB designates the Jefferson County Business & Workforce Center located at 3500 Illinois Street, Golden, CO 80401, as the comprehensive workforce center for the Tri-County Workforce Area.

III. Services Description Exhibits

1. The One-Stop Partner avers that, as of the Effective Date, the Service Description Exhibit,

a copy of which is attached hereto as Exhibit A, accurately and completely sets forth: (a) the specific services that the One-Stop Partner provides in the Tri-County Workforce Area, including the manner in which such services will be coordinated and delivered in the Tri-County Workforce Area; (b) the methods of referral of individuals between the One-Stop Partner and the one-stop operator for the Tri-County Workforce Area for appropriate services and activities; and (c) the methods used by the One-Stop Partner to ensure the needs of workers and youth, and individuals with barriers to employment, including individuals with disabilities, are addressed in the One-Stop Partner's provision of necessary and appropriate access to services, including access to technology and materials.

2. Throughout the term of this MOU, the One-Stop Partner agrees to provide the services, to comply with the referral methods, and to provide the methods of access set forth in the Service Description Exhibit.
3. The One-Stop Partner agrees to promptly update its Service Description Exhibit if, for any reason, the Service Description Exhibit no longer accurately or completely describes the services provided, or the referral or access methods used, by the One-Stop Partner. In the event that the One-Stop Partner updates its Service Description Exhibit, the One-Stop Partner shall provide the updated Service Description Exhibit to the TCWDB and Jefferson County for their review and approval. If the TCWDB and Jefferson County approves the proposed updates, the TCWDB and Jefferson County shall accept the updated Service Description Exhibit, update this MOU to reflect the new Service Description Exhibit, and provide a copy of the updated MOU to all Parties and all other one-stop partners operating in the Tri-County Workforce Area. All requests to update the Service Description Exhibit shall be made on forms approved by the TCWDB and Jefferson County.
4. The TCWDB's and Jefferson County's acceptance of a One-Stop Partner's updated Service Description Exhibit and provision of notice in accordance with Section III(3) of this MOU shall be sufficient to constitute an amendment of such exhibit.

IV. Infrastructure Funding

1. The Infrastructure Funding Agreement (the "IFA"), which is attached hereto as Exhibit B, sets forth the Parties' understanding regarding the funding of the one-stop delivery system in the Tri-County Workforce Area, including without limitation (a) the effective time period of the IFA; (b) identification of the chief elected official, the local workforce development board and all one-stop partners participating in the funding of the Tri-County Workforce Area's one-stop delivery system; (c) the infrastructure and shared services budget for the Tri-County Workforce Area; (d) the One-Stop Partner's cost allocation and budget; and (e) a description of the periodic review and reconciliation process to ensure equitable benefit among the one-stop partners.
2. The IFA is hereby incorporated as a legally binding component of this MOU as if fully set forth herein.

V. Modifications and Amendments

1. The procedure for amendments to the Service Description Exhibits are set forth in Section III of the MOU.

2. The IFA may be amended to update the list of participating one-stop partners and to update budgeted numbers in accordance with the processes outlined in Sections III and VIII of the IFA, respectively.
3. Any Party to this MOU may change its authorized representative or contact information by providing notice of such change to all Parties in accordance with Section VII(12) of the MOU.
4. If the One-Stop Partner is not a Required Partner, as that term is defined in WIOA, the One-Stop Partner may terminate this MOU by providing a minimum of ninety (90) days' notice to all other Parties. If the One-Stop Partner terminates this MOU, the One-Stop Partner is no longer eligible to participate as a one-stop partner in the Tri-County Workforce Area and will not be permitted to appoint a representative to serve on the TCWDB. The One-Stop Partner's rights and obligations under this MOU shall cease on the effective date of such termination, with the exception of any liabilities which the One-Stop Partner may have incurred prior to termination, and the Party's confidentiality obligations under this MOU.
5. If this MOU is terminated, the TCWDB and Jefferson County shall provide notice of such termination to all remaining one-stop partners in the Tri-County Workforce Area.
6. Any other modifications to the terms of this MOU, including without limitation any modifications to the terms of the IFA, shall require an amendment signed by authorized representatives of all Parties.

VI. Appropriations/Funding

1. The obligations of all governmental Parties under this MOU (including those obligations set forth in any exhibit to this MOU) are subject to and contingent upon the availability, appropriation and encumbrance of funds for such purpose. In the event that such funding is reduced or eliminated, such Party may modify its obligations under this MOU accordingly.
2. None of the Parties, by this MOU, irrevocably pledges present cash reserves for payments in future fiscal years. The MOU does not and is not intended to create a multiple-fiscal year direct or indirect debt or financial obligation for any Party.

VII. Miscellaneous Provisions

1. Governing Laws. In the performance of their obligations under this MOU, the Parties agree to comply with the Workforce Innovation and Opportunity Act, as amended, 29 U.S.C. §§ 3101 *et seq.*, the Wagner-Peyser Act, 29 U.S.C. §§ 49 *et seq.*, the Rehabilitation Act of 1973, 29 U.S.C. §§ 720 *et seq.*, the Adult Education and Family Literacy Act, 20 U.S.C. §§ 9201 *et seq.*, the Colorado Career Advancement Act of 2016, C.R.S. §§ 8-83-201 *et seq.*, as amended, all applicable Training and Employment Notices and Training and Employment Guidance Letters issued by the United States Department of Labor, and all applicable Policy Guidance Letters issued by the Colorado Department of Labor and Employment.
2. Record Maintenance and Inspection. Each Party shall make, keep and maintain a complete file of all records, documents, communications, notes and other written

materials, and electronic media files, pertaining in any manner to the performance of this MOU until the later to occur of: (i) a period of six (6) years after the date this MOU expires or is earlier terminated, or (ii) the resolution of any pending disputes arising out of or relating to this MOU or the Parties' rights and obligations hereunder. This section shall be deemed to supplement and not replace any additional record maintenance and inspection requirements that a Party's funding authority or program may be bound by. All Parties shall continue to adhere to such other record maintenance and inspection requirements in addition to those set forth in this section.

3. Confidentiality. The Parties may have access to and contribute to information and materials of a highly sensitive nature, including confidential information. During the term of this MOU and at all times thereafter, the Parties shall not use or disclose any confidential information except to the extent such use or disclosure is necessary in the performance of this MOU. In accordance with but not limited to 20 CFR Part 603, 45 CFR Section 205.50, 20 USC 1232g and 34 CFR part 99, and 34 CFR 361.38, as well as applicable state and federal law, rules, regulations, and waivers, all Parties shall actively secure and share confidential participant information and records only with each other. The Parties shall not share another Party's confidential information unless allowed by state and federal law, rules, regulations, and waivers.
4. Dispute Resolution. If one or more Parties disagree on the implementation of this MOU or the performance of services hereunder, the Parties will attempt to resolve their disagreement through negotiation. If the Parties cannot reach a resolution through this negotiation, the TCWDB will attempt to resolve the differences with the assistance of the Parties involved.
5. Integration Clause. This MOU embodies the entire agreement between the Parties referring to the subject matter hereof. The Parties recognize and agree that no Party has made or authorized any understanding beyond that expressly set forth in the MOU, and no oral representation, promise, or consideration different from the terms herein contained shall be binding on any Party.
6. Severability. Should any provision of this MOU be held to be invalid or unenforceable, then the balance of the MOU shall be held to be in full force and effect as though the invalid portion was not included.
7. Independent Contractor. The Parties recognize and agree that each Party is an independent contractor for all purposes, both legal and practical, in performing services under this MOU, and that each Party and its agents and employees are not agents or employees of the other Party for any purpose. As an independent contractor, each Party shall be responsible for employing and directing its own employees and agents as is required to perform the services provided pursuant to this MOU, and shall exercise complete authority over its own personnel and agents, and shall be fully responsible for their actions. Each Party acknowledges that their agents and employees are not agents or employees of any other Party, for any purpose.

Nothing in this MOU will be construed to make one Party an employee, franchisee, joint venturer, agent or Partner, of another Party. No Party will represent itself to have any authority to bind any other Party to act on its behalf, except as expressly set forth herein. No Party will have the right to represent itself as having the authority to pledge another

Party's credit or extend credit in another Party's name. No Party will have the right to execute any agreements in another Party's name, or to bind another Party in any way.

The Parties acknowledge that they are not entitled to unemployment benefits or workers compensation benefits from another Party, its elected officials, agents or any program administered or funded by another Party. The Parties shall be entitled to unemployment coverage or workers compensation insurance only if unemployment compensation coverage or workers compensation coverage is provided by that Party's Program or some other entity that is not a Party to this MOU.

8. Governmental Immunity. Liability for claims for injuries to persons or property arising from the negligence of any governmental parties, their departments, institutions, agencies, boards, commissions, committees, bureaus, offices, officials, and employees shall be controlled and limited by the provisions of the Governmental Immunity Act, C.R.S. § 24-10-101, et seq., the Federal Tort Claims Act, 28 U.S.C. Pt. VI, Ch. 171 and 28 U.S.C. 1346(b), and the risk management statutes, C.R.S. § § 24-30-1501, et seq., as amended.
9. Third-Party Beneficiaries. The enforcement of the terms and conditions of this MOU and all rights of action relating to such enforcement, shall be strictly reserved to the Parties, and nothing contained in this MOU shall give or allow any claim or right of action whatsoever by any non-Party. It is the express intent of the Parties to this MOU that any person receiving services or benefits under this MOU shall be deemed an incidental beneficiary only.
10. Assignment. The Parties' rights and obligations hereunder are personal and may not be transferred, assigned, or subcontracted without the prior written consent of the TCWDB. Any attempt at assignment, transfer, or subcontracting without the written consent of the TCWDB shall be void.
11. Compliance with Law: The Parties shall strictly comply with all applicable federal and state laws, rules, and regulations in effect or hereafter established, including, without limitation, laws, rules and regulations applicable to discrimination and unfair employment practices. Any changes to such laws are deemed to have been incorporated into this MOU as of the date such changes take effect.
12. Notices: For all notices required to be provided under this MOU, all such notices shall be in writing, and shall be either sent by certified mail, return receipt requested, emailed or hand-delivered to the following representatives of the Parties at the following addresses.

13. Ownership of Materials and Information. Unless otherwise provided for in this MOU, the Parties agree that all material, information, data, computer software, documentation, studies, and evaluations produced by any Party in the performance of this MOU are the sole property of such Party.
14. Conflict of Interest. Each Party acknowledges that with respect to this MOU, even the appearance of a conflict of interest is harmful to the Parties' interests. Each Party shall refrain from any practices, activities, or relationships that reasonably may appear to be in conflict with the full performance of such Party's obligations under this MOU.
15. Authorization. Each person signing this MOU represents and warrants that he or she is duly authorized to execute this MOU. Each Party represents and warrants to the other Parties that the execution and delivery of this MOU and the performance of such Party's obligations have been duly authorized.
16. Counterparts: This MOU may be executed in multiple identical original counterparts, all of which shall constitute one agreement.
17. Notice of Pending Litigation. Each Party shall notify the other Parties, in writing, within five (5) business days after being served with a summons, complaint or other pleading filed in any federal or state court or administrative agency that involves services provided under this MOU or is otherwise related to this MOU.
18. CORA Disclosure. To the extent not prohibited by federal law, this MOU and its exhibits are subject to public release through the Colorado Open Records Act, C.R.S. §§ 24-71-101, et seq. This MOU is not intended to supersede the Parties' obligations under CORA.
19. Choice of Law. Colorado law, and rules and regulations issued pursuant thereto, shall be applied in the interpretation, execution, and enforcement of this MOU.

RECOMMENDATION

Approval of the application for Colorado Parks and Wildlife Impact Assistance Grant Application.

BACKGROUND

Legislative declaration: The general assembly hereby recognizes that withdrawal of lands from county tax rolls (tax exemption) for the purpose of wildlife conservation and public recreation may create financial impacts on counties in which such lands are located. The general assembly further recognizes that such withdrawal may necessitate financial support and assistance by the state.

Any County in which land is owned by Colorado Parks and Wildlife is eligible to receive annually Impact Assistance Grant funding. Colorado Parks and Wildlife is committed to being a good neighbor in the communities where they own land in fee title for the benefit of wildlife and outdoor recreation.

In order to receive a grant, a County must apply no later than March 6, 2026.

FISCAL IMPACT

Colorado Parks and Wildlife provide the acres for parcels owned in fee title by tax area. The Assessor provides the current mill levies and assessed value per acre, which is calculated per the Department of Property Taxation. I am requesting \$2,439.72 from the Colorado Parks and Wildlife. There are no matching grants. The money helps to offset the cost of general fund services to administer property tax records for Colorado Parks and Wildlife owned land.

BACKGROUND

The Colorado Department of Transportation (CDOT) periodically updates its 10-Year Plan to guide statewide transportation investment priorities and solicits formal input from local governments as part of that process.

Clear Creek County has a direct and substantial interest in the 10-Year Plan because Interstate 70 (I-70) traverses the County and functions as national and statewide infrastructure. Decisions regarding capacity, project sequencing, and design along the I-70 corridor have significant impacts on local public safety, emergency response, community impacts, and long-term fiscal sustainability.

While the County does not control state highways, it plays an important role in identifying local impacts and mitigation needs associated with I-70. Commenting on the Draft 10-Year Plan allows the County to formally document these impacts and advocate for safety and mitigation investments to be addressed concurrently with any additional capacity improvements.

Staff is bringing this item forward for a work session to review the Draft Plan and receive Board direction on Clear Creek County's formal comments and advocacy priorities

CDOT 10-Year Plan Public Comment

Clear Creek County – I-70 Corridor Capacity, Safety, and Mitigation

Jurisdiction / Organization: Clear Creek County

Project / Corridor: Interstate 70 – Clear Creek County Corridor

Comment:

Clear Creek County submits this comment regarding the Colorado Department of Transportation's Draft 10-Year Plan and its proposed investments along the Interstate 70 corridor within Clear Creek County.

Clear Creek County is disproportionately burdened by Interstate 70. While our permanent population is small, the I-70 corridor functions as national and statewide infrastructure, supporting interstate commerce, tourism, freight movement, and regional mobility. The operational, fiscal, and public safety impacts of this corridor, however, fall primarily on Clear Creek County residents and local service providers, while the benefits of increased speed and capacity largely accrue to pass-through travelers.

The projects identified in the Draft 10-Year Plan for the Clear Creek County corridor are overwhelmingly focused on increasing speed and vehicular capacity. While these investments may improve regional travel times, they also create secondary impacts that directly increase local public safety demands. Clear Creek County is already operating over the limit of its ability to absorb these impacts.

Clear Creek County experiences the highest crash rates in CDOT Region 1, with documented crash rates 3 to 10 times higher than other counties in the CDOT Region 1. These crashes translate directly into increased emergency medical responses, law enforcement activity, fire response, roadway incident management, and extended corridor closures. These demands are borne almost entirely by local agencies with limited fiscal capacity and without proportional mitigation funding.

The Draft 10-Year Plan proposes additional capacity without a corresponding, fully funded public safety mitigation framework. Increasing capacity without addressing existing safety deficiencies will further elevate crash frequency and severity, leaving Clear Creek County unable to sustain the resulting public safety obligations. Without meaningful mitigation, these capacity projects risk undermining their own effectiveness as increased incidents and response demands degrade corridor reliability.

This concern is compounded by the lack of progress on previously identified mitigation commitments, including:

- **Idaho Springs Sound Wall (Floyd Hill Project Mitigation)** – noise mitigation for the Idaho Springs community was identified as part of the Floyd Hill project commitments to address increased traffic volumes and speeds. Despite this commitment, the sound wall has not advanced to construction, while capacity improvements associated with the Floyd Hill project continue to move forward.
- **Empire Wildlife Crossing Project** – while included in the Draft 10-Year Plan, this project is currently scheduled no earlier than 2030, despite its documented safety benefits and its role in reducing vehicle–wildlife collisions in a known high-incident segment of the corridor. Deferring this project while advancing capacity and speed improvements places additional strain on local public safety resources and undermines the effectiveness of those capacity investments.

The absence of progress on these mitigation projects undermines confidence that additional capacity investments will be accompanied by the safety infrastructure necessary to protect corridor users and host communities.

Clear Creek County's fiscal reality further constrains its ability to absorb additional impacts. The County's historic boundaries, limited tax base, and extreme visitor-to-resident ratios mean that increased I-70 demand directly stresses local services without generating proportional local revenue. Emergency response to I-70 incidents already represents a disproportionate share of County public safety activity, and continued escalation without mitigation is not financially sustainable.

Clear Creek County urges CDOT to recalibrate the Draft 10-Year Plan for the I-70 corridor to:

1. **Prioritize safety and mitigation projects at the same level as capacity projects**, rather than treating them as secondary or discretionary.
2. **Fully fund public safety mitigation measures** necessary to support any increase in corridor capacity, including wildlife crossings, noise mitigation, emergency response infrastructure, and incident management improvements.
3. **Demonstrate measurable progress on existing mitigation commitments**, including the Idaho Springs Sound Wall and Empire Wildlife Crossing, before advancing additional capacity expansions.
4. **Recognize that capacity without safety is not a viable long-term strategy**, and that failure to address this imbalance will ultimately compromise both corridor performance and local government sustainability.

Clear Creek County supports transportation investments that improve safety, reliability, and resilience. However, additional I-70 capacity without concurrent, funded safety mitigation places an untenable burden on local governments and public safety providers and risks undermining the very goals the 10-Year Plan seeks to achieve.

CDOT 10-Year Plan Public Comment

Clear Creek County – Bakerville Climbing Lane and Context Sensitive Solutions

Clear Creek County submits the following comment regarding the proposed Bakerville climbing lane, which is identified in the Record of Decision (ROD) and is listed as the lead improvement in the Draft CDOT 10-Year Plan for the I-70 corridor.

The Bakerville climbing lane would expand Interstate 70 in one of the most constrained, environmentally sensitive, and operationally complex locations in Clear Creek County. This segment of the corridor is characterized by steep grades, limited right-of-way, sensitive natural resources, and existing public safety challenges, including high crash rates, difficult emergency access, and frequent incident-related closures.

As currently positioned, the Bakerville climbing lane represents a significant capacity expansion in a location where Clear Creek County already experiences disproportionate public safety and operational impacts from Interstate 70. As documented in prior County and CDOT analyses, Clear Creek County has the highest crash rates in CDOT Region 1, and increased capacity in constrained mountain segments has the potential to exacerbate crash severity, response times, and emergency service demand if not paired with robust mitigation.

Clear Creek County intends to fully participate in the Context Sensitive Solutions (CSS) process associated with the Bakerville climbing lane. Given the scale and sensitivity of this project, the County believes it is essential that a formal, well-defined CSS process be established early, with clear expectations for local government involvement, mitigation development, and sequencing.

The County should be engaged as a partner at the outset of the CSS process, not merely as a commenting agency after key design assumptions have been set. Early coordination is necessary to ensure that public safety impacts, emergency response needs, community concerns, environmental constraints, and cumulative corridor effects are meaningfully incorporated into project development.

Clear Creek County further emphasizes that advancing the Bakerville climbing lane as the lead project in the 10-Year Plan without concurrent and prioritized safety and mitigation investments risks repeating past challenges along the I-70 corridor. Capacity improvements in isolation place additional strain on local governments and can ultimately undermine corridor performance if crashes, incidents, and response demand increase.

Accordingly, Clear Creek County requests that CDOT:

1. **Ensure a formal CSS process is established for the Bakerville climbing lane**, with early and sustained County participation.
2. **Engage Clear Creek County in initiating and shaping the CSS process**, including identification of mitigation needs and public safety considerations.
3. **Align the timing of the Bakerville climbing lane with prioritized safety**, mitigation, and incident response improvements, rather than advancing capacity ahead of mitigation.
4. **Recognize the Bakerville segment as a high-risk**, high-impact location where additional capacity must be carefully balanced with safety, environmental protection, and local service sustainability.

Clear Creek County supports thoughtful, collaborative transportation planning. However, given the sensitivity of the Bakerville location and its designation as the lead improvement in the Draft 10-Year Plan, it is critical that this project proceed only with strong local partnership, a rigorous CSS process, and clear commitments to safety and mitigation.
