WHEREAS, the Board of County Commissioners desires to acknowledge the appointment to certain positions of members of the public which assist the County; and


WHEREAS, the formal appointment of these positions will assist in promoting the general welfare of the residents of Clear Creek County.

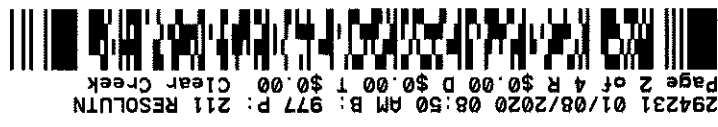
